The case was against the head of orthopedics of a North Jersey hospital who failed to diagnose and treat compartment syndrome of a patient's leg after surgery.

Maggiano, an experienced and accomplished attorney, leads the firm. Defense and fellow plaintiffs' attorneys highly regard Maggiano, who is a past president of the Association of Trial Lawyers of America-New Jersey and an advocate member of the American Board of Trial Advocates. As an adjunct to his construction injury cases, DiGirolamo brings his trial experience to the field of workers' compensation, in which he represents severely injured and disabled workers. Both Maggiano and DiGirolamo frequently lecture on personal injury law for various bar groups. This year, Michael Lizzi, a member of the firm since 1999, has been included on the Super Lawyers list. He has developed extensive experience in complex litigation in New Jersey as well as New York, and heads the firm's New York litigation department. He has achieved many large recoveries for the seriously injured and families who have lost loved ones as a result of individual, professional and corporate negligence.

Most recently, Lizzi secured a recovery of \$1.3 million from the state of New York for a young man seriously injured after the car he was riding in swerved off the roadway and plunged down an embankment. Lizzi successfully argued that the state should compensate the young man because it failed to install guardrails at the location in 1946, despite the protection afforded the state under a qualified immunity.
